Mendips & Forthlin Road

Way back in January **Local History Group 9** planned a visit to John Lennon and Paul McCartney's childhood homes concerned that if we didn't book early then the tours would likely book up.

The tour departed, by minibus, from Liverpool SouthParkway; firstly the driver took the group to John's home (Mendips), which is on Menlove Avenue and then on to Forthlin Road, which is the best known of Paul's childhood homes. A different tour guide welcomed the group at both houses and each provided a real insight into John and Paul's humble beginnings, their early friendship and their musical partnership. Both boys sadly lost their mothers when they were young and this was a catalyst that bonded their friendship and creativity.

Mendips, the childhood home of John Lennon, is a 1930s semi-detached house and is more luxurious than Forthlin Road. It was lovingly maintained by John's Aunt Mimi and you can still see the house and garden as it was when John lived there, it is neat and tidy, yet still cosy. John's mum Julia was run over in 1958 when crossing the road outside Mendips. Forthlin Road is a typical example of a post-war terraced council house, it is smaller and more basic than Mendips. Paul's mother, Mary, died in 1956 when he and his brother, Mike, were in their teens and they lived there with their father Jim until the Beatles became famous.

It is surreal to stand in these houses knowing that John and Paul wrote several of the group's earliest hits when they were sagging off school!! e.g. Please Please Me, I Call

Your Name, I Saw Her Standing There and She Loves You. You can even tinkle the ivories on Jim McCartney's piano, which obviously Paul has also played many times.

Both residences are under the ownership of the National Trust and this tour is the only way to see inside the houses where John and Paul grew up and the Beatles were born. This really is a trip down memory lane and photographs taken by Mike McCartney featuring John and Paul hang on the wall in Forthlin Road. Everyone was buzzing after the tour, which is a must do for anyone who has ever heard of the Beatles. When group members were asked if they had enjoyed the tour they responded Yeah, Yeah, Yeah!!!



Murder and Mystery

We were given details of the murder and a brief description of what the area would have looked like in the early 1900s. The tour continued to a few other locations in the old business district where other murders were either committed, or where the murderers lived/worked. One story even involved a connection to "Jack the Ripper." I won't tell any more but the Group found the tour to be very interesting and many questions were answered providing a mental image of times gone by. Because the tour ended in the lunch time period the group split up into smaller groups to enjoy a meal in one of the many restaurants in the busy business area of the city.

Do You Know The Best Way To Outwit Fraudsters This Christmas?

If you use text messaging, or e-mails, or buy from websites you need to know how to beat fraudsters! Check out these tips and how to keep your bank card details safe.

Criminals can use fake websites, emails, and text messages to convince you to give them your card information. Once they've stolen your details, they can spend your hard-earned money, open new accounts and even apply for loans in your name.

So here's some tips for recognising when a website isn't all it seems, and how you can protect yourself online.

Suspicious messages will:

- **Addresses you by your email address, or as “customer,”** rather than using your proper name.
- **Demand that you act quickly,** otherwise you risk losing something.
- **Contain links that ask you to click on part of the message.** Don't click on it, even if the message appears to have come from a person, or a business you know. Instead go to the businesses website and log in.
- **Appear to come from a trusted source like a friend.** Your friend appears to be in “distress”, such as “I've had my money stolen; please send me £”, or “my phone is broken and I need your help,” or could ask “do you recognise these people,” with a link to what is meant to be pictures but is actually a link to a system so that they can access your phone or computer or you could arrive on a site or form that looks OK but asks you to give personal information and card details, which may be used to steal your money.
- **Ask you to update your address,** pay a bill or fine (which you didn't even know you owed).
- **Prompt you to unblock, or unfreeze your account** (which you didn't know was frozen and if you check directly with the company isn't blocked).
- **Prompt you to reschedule a missed delivery,** often for a charge (which you didn't know was on its way).
- **Often contain spelling and grammar mistakes:** Genuine websites will have correct spellings and grammar. Scamming messages often start life abroad and are written by people who do not have English as their first language.

How to spot fake online retailers

🔒 **Before you buy check for a padlock symbol in the address bar or browser**
The padlock indicates that the site is encrypted, so what you do on it can't be intercepted. Looking for a padlock should always be combined with the other checks, as scammers are able to forge or buy these padlocks, so it isn't a guarantee that a

website is safe.

Control your card's security

Banks and legitimate retailers will not ask you for full details of your security codes or pin numbers. They may ask you for e.g. 1st and 3rd letter/number etc. but NEVER the full password/PIN.

If you think someone is trying to trick you into handing over money, or personal details, or you think your card details are at risk, or if your account is displaying transactions that you don't recognise - **stop the call, hang up and call 159**. 159 works in the same way as 101 for the police, or 111 for the NHS. It's the number you can trust to get you through to your bank safely and securely, every time.

Use the telephone number on your card. **DO NOT use the telephone number in any suspicious e-mail you receive.**
